SECTION 4: First aid measures

4.1 Description of first aid measures

General notes

Do not leave affected person unattended. Remove victim out of the danger area. In case of unconsciousness place person in the recovery position. Never give anything by mouth. Take off immediately all contaminated clothing. In all cases of doubt, or when symptoms persist, seek medical advice.

Rinse mouth with water (only if the person is conscious). Do NOT induce vomiting.

Wear suitable gloves. Check leak-tightness/impermeability prior to use. The selection of the suitable gloves does not only depend on the material, but also on further marks of quality and varies from manufacturer to manufacturer.
